I/we also realize that SSC, and its judges, sponsors and partners have had, and will have, access to and/or may independently create, or may have created, ideas identical to the theme, plot, characters, format or other elements of the Material, and I/we hereby agree that I/we will not be entitled to any compensation by reason of the use by SSC, or any of its judges, sponsors or partners, of such similar or identical material and, moreover, hereby agree not to bring any action or claim against SSC, its judges, sponsors or partners, or any of their officers, directors, employees, subsidiaries, affiliates, successors and assigns, arising out of or related to my/our submission of the Material.

I/we will indemnify and hold harmless SSC, its judges, sponsors and partners, and each of their respective officers, directors, employees, subsidiaries, affiliates, successors and assigns, as applicable, individually and collectively, from and against all claims, demands, losses, damages, costs, liabilities and expenses including legal expenses arising out of or in connection with the Material submitted to SSC.
